1. I wish to participate in indoor activities including Virtual Reality and Motion Simulation.
2. I am at least eighteen years old or am signing for the children detailed above who are in my care.
3. I acknowledge that I am responsible for my own safety (and the safety of my possessions) while undertaking the activities.
4. I certify to the best of my knowledge that neither I nor the children who I am supervising, if applicable, have a medical condition (including epilepsy) which might have the effect of making it more likely that I

will be involved in an incident which could result in injury to myself or others. If I am not the parent/guardian of the children whom I am supervising, I confirm that I have checked with their parent/guardian that they do not have any such condition, or that this is known by me prior to the simulation session.

5. I am the parent/guardian of the child or children listed above who is/are under 18 years of age. I wish that/those child/children participate in VR and Motion Simulation activities, and declare that if I am not the parent or guardian of the child or children that I have the authority from the child or children's parent or guardian to sign this form.

6. I agree that I am responsible for the child or children in my care and undertake to ensure that he/she/they undertake any activities in accordance with any safety rules, whether written or given orally, and any to follow any other advice that I/they have received prior to booking, during booking or during the session.

7. I acknowledge that I am responsible for the safety supervision of the child or children named above (and the safety of our possessions).

8. In the unlikely event of an accident, or loss or damage to any personal effects or those of any third party, I acknowledge that VR Sim Ltd will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the activities (except for death or personal injury caused by the company's negligence) and I waive any and all claims against VR Sim Ltd in this respect.

9. I acknowledge that I/we are not to enter or exit the motion simulator rig unless specifically instructed to do so by an employee of VR Sim Ltd.

10. I acknowledge and accept that the activities may incur feelings of motion sickness, disorientation and confusion, either during or for a short period after engaging in the activities. I acknowledge that these symptoms are usually short lived. I have also been advised that I am free to remove the VR headset at any point during a simulation and participate using a fixed screen instead.

11. I specifically acknowledge that I will heed all advice given before the start of, or during the session as regards to steering controls during simulated racing/driving. Notably, that feedback through the steering wheel can be very strong, and that I/the child and/or children I am supervising have been advised to let go of the steering wheel during a simulated 'crash' or other simulated 'racing incident'. Force Feedback (FFB) from the steering wheel may cause injury to the fingers, hands and/or wrists. I fully and openly acknowledge these risks and am choosing to participate myself, and/or am giving consent for the children who I am caring for to participate. I acknowledge that FFB on these steering wheels can be as much as 20nm of torque applied in a twisting/rotating manner, and I am choosing to accept these risks.

12. I also acknowledge that VR Sim Ltd operates a zero tolerance policy for rage gaming. If I or anyone that I am supervising 'rages' during gaming, demonstrates unacceptable behaviour or wilfully damages any motion equipment, input or output devices, computers, screens or other property during my session, that that session will be immediately forfeit with no refund, and I will be liable for the full cost of repairs and/or replacement of that equipment, no matter how the damage is incurred. VR Sim Ltd also has a zero tolerance policy to abuse of other players and/or staff members and applies the same terms to this behaviour. The exhibition of the above behaviour(s) will be determined at the complete discretion of VR Sim Ltd and its employees.
